**IRS & 990 FORMS:** All Lioness clubs that do not have their own tax ID numbers are advised to obtain one ASAP. The application form is available on the IRS web site. The IRS is requiring all non profit organizations to report a 990 each year. If you have not reported to the IRS, either through the Lions club or individually for the past 3 years, you are in danger of losing your tax exempt status. YOU HAVE UNTIL OCTOBER 1<sup>ST</sup> TO CORRECT THE SITUATION. By applying now, your club will be recognized as a new entity by the IRS and your filing requirement begins now. Your bank may need to view your club constitution, By-Laws, yearly budget, and a year end statement. If you have your club charter, that will take the place of the constitution and by-laws. The
